



INJECTION CONSENT FORM

TO THE PATIENT

This form and your discussion with your doctor are intended to help you make an informed decision about your biopsy. As a member of the treatment team, you have been informed of your diagnosis, the planned procedure, the risks, benefits, and alternatives associated with the procedure, and any associated costs. You should consider all the above, including the option of declining treatment, before deciding whether to proceed with the planned procedure. Your doctor will be happy to answer any questions you may have and provide additional information before you decide whether to sign this document and proceed with the procedure.

I voluntarily request for **Austin Neuromuscular Center physicians & associates**, technical assistants, and other healthcare providers as they may deem necessary, to treat a condition that has been explained to me.

1. I understand that my physician may discover other or different conditions which require additional or different procedures than those planned.
2. I authorize my physician, and such associates, technical assistants, and other healthcare providers to perform such other procedures which are advisable in their professional judgment.

Just as there may be risks and hazards in continuing with my present condition without treatment, there are also risks and hazards related to the performance of the surgical, medical, or diagnostic procedure planned for me. I realize that common to surgical, medical, and other diagnostic procedures are the potential for infection, blood loss, allergic reaction, and even death.
5. I understand with the administration of Botox or steroid injections there might be a chance of: a severe allergic reaction (rash, hives, itching, difficulty breathing and tightness of chest, swelling of the face); bleeding at the injection sites; burning, numbness, or tingling; difficulty swallowing or breathing; double or blurry vision; droopy eyelids; fainting; fever or chills; persistent sore throat; irregular heartbeat; loss of strength; paralysis; seizure; severe or persistent muscle weakness; headache; dizziness; speech changes; worsening migraines; shortness of breath; limb pain; back pain; drowsiness; dry mouth; dry/irritated eyes; facial pain; flu-like symptoms; neck pain; runny nose; sensitivity to light; tenderness at the injection site.
6. I have been given an opportunity to ask questions about my condition, alternative forms of anesthesia and treatment, risks of non-treatment, the procedures planned to be used, and the risks and hazards involved, and I believe that I have sufficient information to give this informed consent.
